Preliminary Remedial Actions to Begin at State Superfund Site

Construction Actions are beginning in order to provide an alternate water supply for the Village of Hoosick Falls in Rensselaer County. The alternate water supply is necessary based on contamination related to the Saint-Gobain McCaffrey Street site ("site") located at 14 McCaffrey Street, Hoosick Falls, Rensselaer County, which is being remediated under New York's State Superfund Program. Please see the map for the site location and the project area. These activities will be performed by Honeywell International and Saint-Gobain Performance Plastics with oversight provided by the New York State Department of Environmental Conservation (NYSDEC) pursuant to a legal agreement with the companies.

These preliminary activities are expected to begin in August 2023, and last about two months.

Highlights of the Upcoming Actions: The goal of the actions in the project area is to protect the two test wells located at the LaCroix Property. The action is in preparation for the water main and pumphouse construction, which is part of the Operable Unit 2 (OU-2) remedy selected by the NYSDEC in the December 2021 Record of Decision (ROD). The key components of the construction are:

- Excavation of the existing riverbank and riprap protection measures through the installation of 555.2 cubic yards (cy) of material below the ordinary high water mark (OHWM).
- Grading and installing a geogrid and placing heavy stone riprap (stone)
 of which 463.5 cy will be installed below the OHWM, to create a stable
 slope and well protection.
- Installing and maintaining erosion and sediment control measures in accordance with the New York State Standards and Specifications for Erosion and Sediment Control (cofferdam or equivalent).

- ▶ NEW WATER SOURCE PIECE #1 Bank Stabilization
 - ▶ Part of the river bank near the LaCroix site/new well field required some additional stabilization, about 7,3000 feet total.
 - Work required design, review by Village, review/approval by DEC, and permit from ACE.
 - ► Work would include work in the river that must be done by September 30th; work on land to be done by October 30th.

- ▶ NEW WATER SOURCE PIECE #1 Bank Stabilization
 - ▶4/14 Update: Goals to have 60% design by mid-May, 100% Design by mid June, RFP, pre-screening done, and be in the field in mid-August
 - ▶8/15 Update: On schedule, permits in hand. Will finish river-related work by September 30th (due to fish spawning deadline), with all work to be done by end of October.

- NEW WATER SOURCE PIECE #2 Well Development and Property Purchase
 - ▶<u>8/15 Update</u>: Two wells are being developed on the LaCroix property, everything is going well (quality, volume).
 - ► Companies working with owner to acquire this property, likely closing in mid-fall. No time delay thus far.

 - ▶Overall project will feature two new wells, piped up Rt 22 and then under river (not across/under bridge by Tops), then hooked into Water Treatment Plant/existing lines.
 - ▶Well 7 will remain as a backup, Well 3 and 6 will no longer be operational.
 - Sentinel (Observation) Wells developed around new wells to test regularly for possible migration.
