Municipal Building AC/Heat System checking to see if the current system in the courtroom could be connecting to the rest of the building.

OLD BUSINESS

Update on Sidewalk Safety Issue along Classic St/Route 22. Atty. Gilchrist discussed the status of eminent domain in regards to the property along Classic St. and Rt. 22. He gave the board a draft of a new Local Law that would repeal Local Law #1 of 2008 it would be a Local Law providing for the identification and repair or removal of unsafe building's, structures and sites. The board will look at this and look to adopt this new Local Law.

NEW BUSINESS

Motion to reconsider Bond Resolution for the purchase of a Sewer Vac Truck made by Dep. Mayor Ryan seconded by Tr. Schuttig all in favor none opposed. Village Treasurer Denise McMahon explained the terms to the board, originally passed in August 2021 for \$109,271 over 5 years, goal is change to 15 years.

Resolution amending a bond resolution in connection with the purchase of a sewer vac truck, to be extended the maximum maturity of bonds authorized to be issued beyond five years was offered by Dep. Mayor Ryan seconded by Tr. Walraed all in favor Tr. Decker absent.

ARPA Funds

The board looked over the different ideas they had discussed for ARPA funds and decided to wait to discuss further at the next meeting when Tr. Decker was back.

Motion was made to accept the bid from JA Bradley to install 7 gfci receptacles on streetlight poles for an amount not to exceed \$3000 made by Dep. Mayor Ryan seconded Tr. Schuttig all in favor none opposed.

Discussion regarding the condition of the leachate pump system was had the pump is not working and LaBella had a proposal to remove the old pump and lease a new pump they would be using the existing financing for this and the future of the pump will be discussed with Environmental Engineer Millspaugh at a special meeting next week.

Motion to approve task 1 as set forth from Labella's letter of 7/7/22 and Stirling Letter of 7/12/22 was made by Dep. Mayor Ryan seconded Tr. Schuttig all in favor none opposed.

Motion to approve the relevy corrections for 10 Rogers Ave. and 14 Madison St was made by Dep. Mayor Ryan seconded Tr. Walraed all in favor none opposed.

Motion to approve a relevy correction on 3 Wall St. made by Tr. Walraed seconded by Tr. Alter all in favor none opposed.

Motion to allow Mayor Allen to approve the contract for the new phones from Nextiva for the lobby and the Highway garage was made by Tr. Schuttig seconded by Dep. Mayor Ryan all in favor none opposed.

Motion to have the residential property appraised on Ashley Drive at fair market value the appraisal not to exceed \$1000 made by Dep. Mayor Ryan seconded by Tr. Schuttig all in favor none opposed.

Motion to accept the resignation of police officer Ryan Ashe was made by Dep. Mayor Ryan seconded by Tr. O'Malley all in favor Tr. Schuttig excused himself.

Motion to go into Executive Session to discuss personnel matter and pending litigation (with no business to be conducted at conclusion of Executive Session) made by Tr. Schuttig seconded by Tr. Walraed all in favor none opposed.
