TRUSTEE/COMMITTEE REPORTS

Tr. O'Malley thanked all those involved in the tree lighting, Arron Buzzinski, Dave Sutton and JC Tractor for driving Santa. Tr. O'Malley said it was well attended and started the holiday weekend off in a great way. He also brought up the parking study for the downtown area as well as an overall study, the board discussed the possibilities that some funds may be available with grants and they are going to look into that. Tr. O'Malley mentioned that the board needs to decide on the Snow Emergency policies and they need to be enforced. They discussed who called the snow emergency the Mayor or the Highway Superintendent. Also, the need to have a tow company that can tow the cars so far only have one that will help in the daytime. Tr. O'Malley also mentioned several lights out one on the corner of John and Main St. and Elm and Church St.

Tr. Decker mentioned that the village should look at a stop sign on the crossroad of Railroad Ave. and Elm St. with more traffic that goes through there between two local businesses, Tr. Walraed is going to check on any Local Laws that may apply to putting up stop signs.

Tr. Schuttig mentioned that the Village is putting in for the Restore NY grant for 1 Center St. which is being bought by Jasen VonGuiness, we will need to hold a public hearing on this grant at the January 2023 meeting.

Tr. Walraed spoke to the water departments need still for a new truck, as well as the need to consider a new more efficient dehumidifier for the plant.

Dep. Mayor Ryan mentioned that Real Term has posted the material bid for the street lights so they are moving forward.
